sand or other suitable material. Place in non leaking containers. Flush area with water to remove trace residue. Minimize breathing vapors and skin contact, ventilate confined area, open all windows and doors, assure conformity with applicable government regulations. Keep all nonessential people away.

## 7. HANDLING AND STORAGE

Store large quantities only in buildings designed to comply with *OSHA 1910.106*. Keep containers tight and upright to prevent leakage. Do not store with incompatible materials. Keep containers closed when not in use. Keep away from open flames and high temperatures.

Do not take internally. Avoid prolonged or repeated contact with skin, eyes, and clothing. Wash thoroughly after handling. This resin may be handled, shipped and stored at elevated temperature in bulk. The recommended pumping temperature is 180° F. Containers should be bonded and grounded when pouring.
